Background

### A Brief History

The Dreger Clock was built in the 1930's by Andrew Dreger Sr., whose family were pioneers to the early settlements of Anaheim, Long Beach and Buena Park.

Andrew developed many mechanical skills during his life. He repaired bicycles and other mechanical things, he worked with metal as a blacksmith and other jobs requiring mechanical and hand crafting skills. In the later years of his life he took up watch and clock repair, and became fascinated with the idea of building a large electrically

powered clock that could tell the time in major cities around the world.

He first built a pendulum regulated indoor clock with multiple clock faces. Immediately after completing it he started on the much larger, town clock style version that



would be electrically powered. It took him 5 years to build his masterpiece. When finished he placed it outside his home on Anaheim Street in Long Beach, CA and for almost 20 years he kept it in working order.

Doug announced that a board meeting will take place at the Adams's home on Monday at 7:30.


It was moved and seconded to accept the minutes as published in the Tic Talk Times with the correction that \$100 was collected for the Boy's Republic. Motion passed.

Larry Squires informed the members that the Armillary Sphere had been located at the Acacia House Senior Center.

For the Beginners Corner, Dave Weisbart gave an interesting report on the Time Symposium that he had recently attended. The overall subject of the symposium was the impact of mass production on the American clock industry. The keynote speaker was Dr. Donald Hoak who surmised that the major contributor to interchangeable parts in American mass production was Eli Terry and not Eli Whitney as is generally accepted. Other speakers mentioned clock manufacturers in the years from 1835 through 1850 as major contributors.

The main program for the evening was a presentation

by Jim Glidewell on the restoration of French statue clocks.



statue and other trim parts. A broken base can be repaired using Devcon. The base can be sanded to a dull finish then spray on a clear wood finish gloss which seals the marble to a bright finish. Parts broken off of the

seals the marble to a bright finish. Parts broken off of the statue can also be repaired with Devcon which, after drying, is smoothed with a Dremel tool. The Dremel tool is also used to smooth corrosion and pitting on the statue.

The statue is then hand sanded which can be quite time consuming. The metal is then primed with auto body primer. Jim recommends using a dark bronze metallic paint for the background. To add patina, apply Rub and Buff using a Q tip then use a bristle brush to buff the statue (below, *left*). The gold parts of the statue are spray painted with Gold Plate, available from



Ace Hardware. A gold leafing pen, available from Jo Ann's fabric store, is used to apply highlights to garland, etc. A crystal clear lacquer can then be sprayed to seal it all.

Show and Tell featured a Boule electric clock from about 1920 as shown by Doug Adams. Phyllis Adams brought a Bulova alarm clock whose case was made in Korea. Phyllis also brought a miniature clock from the 1990 NAWCC convention in New Orleans by Creole chapter 43. An Ingersol Fortuna watch from about 1900



was displayed by Bob Selene. Bob claims this to be one of the prettiest watches that he has seen – the color of the case is outstanding. Larry Squires brought a 992B Hamilton watch with the name Donald R Wright on the back (*opposite*, *bottom*). Larry stated that his brother-in-law's name is Donald L Wright. Roy Irick brought a statue of a

mother and baby.

Door prizes were won by Julie Stevens, Elaine Irick and John Maloney.

The meeting was adjourned at 9:18 PM.

When Andrew passed away, his clock was moved to Knott's Berry Farm. Andrew's Sister Emily Dreger Holder was married to a neighbor of the Knott's, so it was fitting that Walter Knott was the one to save the clock for posterity by displaying it first in the "Ghost Town" area of the park in its Rose Garden. Later Knott's placed it out front of their ticket booths. For 50 years the clock fascinated visitors to the park.

But now the clock needs to be rescued for future generations again! The clock fell into disrepair and was eventually taken down from its place in front of Knott's Berry Farm. It disappeared from public view and ended up in a warehouse.

In August of 2007, Glenn Frank, a great grandson of Andrew noticed it was missing from in front of Knott's. With a little searching of the internet he found it again on – of all places – eBay! A few phone calls and emails to local organizations finally put him in touch with the Buena Park Historical Society. BPHS took up the challenge to save



this historic icon of their city and purchased the clock for restoration in October 2007.
